Rebates are available for purchases made January 1, 2018 through December 31, 2020, or until program funds are no longer available, whichever comes first. Due to limited funding, please submit your rebate application as soon as possible after purchase and installation. Equipment must be installed before submitting a rebate application. Rebate applications will be processed on a first-come, first-served basis and must be postmarked or submitted online by January 31, 2021*, to be eligible for rebate.

Furnace	ENERGY STAR qualified and Annual Fuel Utilization Efficiency (AFUE) ≥ 92% Only available in Climate Zone 16 , which includes: Big Bear City, Big Bear Lake, Carnelian Bay, Moonridge, Homewood, Tahoma, Kings Beach, Tahoe City, Olympic Valley, Tahoe Vista, Northstar, Truckee, and South Lake Tahoe	\$200

¹ All new boilers must be installed with modulating burner controls with a minimum 5:1 turndown ratio. New boilers ≥ 10 MMBtuh must also be installed with an O₂ trim control pad. Start-up combustion or thermal analysis report required to demonstrate minimum efficiency and turndown ratio.

² Requires a natural gas-fueled space or water heating system.
