## RATE ALERT

### NATURAL GAS RATE INCREASE – FEBRUARY 2025

On December 27, 2024, Southwest Gas Corporation (Southwest Gas or Company) filed Advice Letter No. (AL) 1321 with the California Public Utilities Commission (CPUC) to recover costs associated the replacement of the North Lake Tahoe Lateral authorized in Decision (D.) 21-03-052. Effective February 1, 2025, your residential gas rates will increase by \$0.117 and \$0.146 per therm, for CARE<sup>1</sup> and Non-CARE customers respectively, or approximately 7%.<sup>2</sup>

A comparison of the average monthly bill for Residential Non-CARE (using 68 therms per month) and CARE customers (using 55 therms per month) is shown below.

#### Reason for Increase:

- The rate increase is due to the replacement of Southwest Gas’ North Lake Tahoe Lateral pipeline authorized in D.21-03-052.

<sup>2</sup> Previous rates (as of 1/1/2025) for CARE and Non-CARE customers were \$1.59 and \$1.99 per therm, respectively. New Rates (as of 2/1/2025) for CARE and Non-CARE customers are \$1.70 and \$2.14 per therm, respectively.

<sup>3</sup> Residential customers average monthly use varies throughout the year with changes in the weather. The impact to your bill may be more of less than shown above based on how much gas you actually use as well as the gas commodity price that fluctuates monthly. Here, the average monthly bill is based on a gas procurement rate of \$0.40527 per therm.
