Please review the rebate application for additional requirements and full terms and conditions.

Rebates are available for purchases made January 1, 2020 through December 31, 2020, or until program funds are no longer available, whichever comes first. Due to limited funding, please submit your application as soon as possible, after purchase and installation. Equipment must be installed before submitting a rebate application. Rebate applications will be processed on a first-come, first-served basis and must be postmarked or submitted online by January 31, 2021\* to be eligible for the rebate.

All Custom projects require **preapproval** before equipment purchase and installation.

### WHAT TYPES OF PROJECTS QUALIFY FOR A CUSTOM REBATE?

2. Be installed in either existing or new construction applications, where the system’s efficiency exceeds applicable codes or standard industry practice
3. Have a minimum useful life of 7 years
4. Exceed minimum cost-effectiveness

## ADDITIONAL INFORMATION TO HELP GET STARTED

- We require preapproval of your project before you purchase and install equipment.
- We will provide written notice if your project qualifies for a *Smarter Greener Better* Custom rebate and the amount you will receive.
- Rebates are calculated on a case-by-case basis with rebates based on the amount of energy conserved.
- After installation and once new processes have been implemented, submit your installation notice along with a commissioning plan and we will verify the completion of your project and send your rebate check.
