TO ALL HOLDERS OF SOUTHWEST GAS CORPORATION'S CALIFORNIA GAS TARIFF

Subject: Revision No. 273 (Advice Letter No. 707)

The attached tariff sheets reflect the authorization granted by the California Public Utilities Commission for Southwest to implement revised general rates in compliance with Commission Decision 04-03-034, approving Application 02-02-012. Application 02-02-012 is Southwest's application for a general rate increase for Southern and Northern California Divisions. Pursuant to the Commission's decision, the attached tariff sheets are effective April 15, 2004.

The major provisions authorized by the Commission are described below:

- The Statements of Rates for Southwest's Southern and Northern California Divisions were revised to reflect the rate and tariff changes authorized by Decision 04-03-034. The sheets also incorporate the latest authorized monthly gas cost rates for April 2004.
- 2. Monthly Basic Service Charges for residential, commercial and noncore general customer classes were increased.
- 3. Except for Rate Schedule Nos. GS-11 and GS-55, all Southern and Northern California rate schedules were consolidated into single rate schedules applicable wherever Southwest serves.
- 4. Section C.3, Service Establishment and Reestablishment Charges, of Rule 3, Applications for Service, was revised to clarify tariff language for "expedited service" scheduling.
- 5. Section F of Rule 9, Rendering and Payment of Bills, was revised to clarify Same Day Service Charge tariff language for expedited service scheduling.
- 6. Southern California Rate Schedule No. GS-45, Core Air-Conditioning, was eliminated and customers were moved to Rate Schedule No. GS-60.
- 7. NonCore Cogeneration, Rate Schedule No. GS-65, and Small Electric Power Generation, Rate Schedule Nos. GS-66 and GN-66, were consolidated into a single rate schedule, No. GS-66/GN-66, Small Electric Power Generation.
- 8. Section 9, the Core Fixed Cost Adjustment Mechanism, and Section 20, the NonCore Fixed Cost Adjustment Mechanism, of the Preliminary Statements were revised to include a Southwest Margin balancing component to track over- and under-recoveries of authorized margins from core and noncore customers.
- 9. Section 8, the Intrastate Transportation Cost Adjustment Mechanism (ITCAM), of the Preliminary Statements, was revised to clarify the components included in the ITCAM and the Revision Date for clearing ITCAM balances.

10. The names of the rate schedules were modified to indicate the consolidation of Southern and Northern California Division rate schedules and numerous changes were made throughout the tariff for consistency to reflect the consolidated rate schedule numbers.

The revised tariff sheets reflecting these changes, C.P.U.C. Sheet Nos. 5826-G through 5894-G, are attached and should be substituted for their respective counterparts currently contained in your copy of Southwest's California Gas Tariff. An index indicating the new sheets and the sheets they cancel is also attached.

Because of the consolidation of Southern and Northern California Division rate schedules, all of the Northern California Division rate schedules are withdrawn. The Table of Contents is now twelve pages, instead of fourteen pages. The various tariff sheets that were withdrawn from Southwest's California Gas Tariff are listed in the attached index, as well, and should be removed from your copy of the Tariff.
